## What is the project rationale?

- Constantly changing political and forest related policy context demand continuous training of actors in the forestry and forest-based sectors.
- There is evident and urgent need for innovative training program in SFM in Austria, Croatia and Slovenia.

## What are the project's objectives?

- to develop innovative curriculum and training materials for VET and life-long learning (LLL) learners in SFM that is multilingual, use information and communications technology (ICT) and open educational resources (OER), in this case e-learning
- to implement the pilot programme transnationally in Austria, Croatia and Slovenia

## What are the main priorities addressed by this project?

- increasing labour market relevance of vocational education and training (VET)
- fostering access to quality VET
